For the convenience of the candidates who are facing the issues while making the online payment for the above joint advertisements due to the wrong information fed by them in application forms, they are advised to contact the office of PPSC on a below given specific email id only as per the type of issue faced by the candidate.

**1. NOT DISPLAYING OF ALL THE REGISTRATION NUMBERS AFTER LOGIN FOR  
ONLINE PAYMENT.**

If the candidate has not fed **“the same 10<sup>th</sup> roll no/year/board”** in all of his/her applications under a particular joint advertisement group as given above, all the registration numbers of the candidate after login to the Online Payment link will not be shown, hence the candidate is required to drop an email **from their registered email id only** at **[reg.number.jointonlinepayment@gmail.com](mailto:reg.number.jointonlinepayment@gmail.com)** **on or before 08/08/2022** with a scanned copy of duly filled **ANNEXURE-A** along with a copy of 10th certificate. After receiving all the required and correct details, all registration numbers of the candidate will be merged together and the candidate can make the payment after 24 hours of dropping email.

**2. NOT DISPLAYING OF ALL THE REGISTRATION NUMBERS or WRONG  
INFORMATION ON THE PAYMENT RECEIPT.**

The candidates who have already made the payment but all of his/her registration numbers are not shown or wrong information is shown on payment receipt, are advised to check again their payment receipt after login. If still there is any problem, candidate must drop an email **from their registered email id only** at **[receipt.jointonlinepayment@gmail.com](mailto:receipt.jointonlinepayment@gmail.com)** **on or before 08/08/2022** with a scanned copy of duly filled **ANNEXURE-B** along with PPSC Payment Receipt and Bank Payment Receipt.

### **3. NOT DISPLAYING THE CORRECT FEE.**

The fee amount shown after the login is as per the fee categories chosen by the candidate during filling of application forms in a particular joint advertisement group. In case the candidate has fed the wrong fee category in any of the application form and the fee amount to be paid is not shown correctly, it is mandatory for the candidate to pay the correct fee amount for considering their candidature in all other advertisements in which all category details fed by them are correct. Candidate also must pay the online fee as shown while making the payment. **For the pending amount, if any**, Candidate is required to drop an email **from their registered email id only** at [feecategory.jointonlinepayment@gmail.com](mailto:feecategory.jointonlinepayment@gmail.com) **on or before 30/08/2022** with a scanned copy of duly filled **ANNEXURE-C and payment receipt of online payment done.**
