- 1. This is for the information of the candidates who have qualified for the interview for the ibid posts that interview schedule (Annexure A) for 20/12/2022 and 21/12/2022 has been uploaded on the website of the Commission.
- 2. It is further informed that the venue for the interview shall be the Office of Punjab Public Service Commission, Patiala and the Reporting Time for the Candidates shall be 8:30 AM (Morning Session) and 1:00 PM (Afternoon session). Late comers shall NOT be allowed to appear in the Interview.
- 3. Candidates MUST bring the following documents (in ORIGINAL) on the day of interview:
 - (a) Proof of Date of Birth: Certificate of Matriculation / Higher Secondary.
 - (b) Proof of having passed Punjabi Language up to matric or its equivalent Standard.
 - (c) Relevant Diploma/Degree and DMC Certificates & Transcript, proof as mentioned in Essential Qualification of General Information.
 - (d) Experience Certificate issued by Competent Authority (If applicable).
 - (e) Caste Reserved Category Certificate issued by the Competent Authority (If applicable).

- (f) Latest Punjab Residence certificate (all Reserve Categories including female candidates who have applied in General Category) issued by competent authority.
- (g) If ESM, Certificate/documents mentioning the following:
 - i) Date of Enrolment
 - ii) Date of Release/Discharge
 - iii) Reasons of Release/Discharge
- (h) Original LDESM Certificate issued by Competent Authority. (if not submitted earlier for scrutiny of said posts).
- (i) Original Documents to claim exemption from Punjabi Language pass up to matric or its equivalent Standard (If applicable).
- (j) Certificate as proof of age relaxation claim (If applicable).
- (k) Certificate as proof of fee concession (If applicable).
- (l) Proof of being Govt. Employee (If applicable).
- (m) Any other certificate, (If applicable).
- (n) Copy of Bank Challan form.
- (o) Duly filled Bio data sheet. The Performa of Bio-data sheet has been attached along with Public Notice as Annexure 'C'.
- 3. Candidates mentioned in Annexure 'B' still have not submitted all requisite essential documents required as per Advertisement. These candidates are conditionally eligible for interview as per schedule mentioned. If these candidates are not able to produce essential documents as mentioned in Annexure 'B' on or before the day of interview, the candidate will not be allowed to appear in the interview and her/his candidature shall be rejected and no further chance will be provided.
