PUBLIC NOTICE

RECRUITMENT TO 159 POSTS OF CIVIL JUDGE (JUNIOR DIVISION) CUM JUDICIAL MAGISTRATE IN THE STATE OF PUNJAB.

1. It is for the information of the candidates who had applied for the ibid posts that, preliminary examination for recruitment to these posts shall be held on **22/01/2023** (Sunday) in various centers at Chandigarh. Punjab Public Service Commission has uploaded Admit Cards for the ibid posts. All the concerned candidates can download their Admit Cards by using their Registration Number and Password on the link Download Admit Card available on the website of the Commission <https://ppsc.gov.in>.
2. The candidature of the candidates who had applied in the category of Sports Persons, Punjab and have been found ineligible in the Sports persons category as per Punjab Recruitment of Sportsmen Rules 1988 amended as per Government of Punjab, Department of Personnel (Personnel policies-1 Branch) Notification No. GSR40/Const. /Art309/Amd. (2)/2020 dated 20.07.2020 will be considered in their base category. The list of these candidates is placed at **Annexure-A**. **The Candidates who have been provisionally allowed by the Hon'ble High Court subject to the outcome of their Civil Writ Petition is at Annexure-B**. The candidature of the candidate who has not submitted the Sports Gradation Certificate shall be considered in the base category and the list of such candidate is attached as **Annexure-C**. **The Candidate whose candidature in the category of Sports Persons, Punjab is under consideration subject to clarification from Director Sports, Punjab is attached as Annexure-D**.
3. It is also informed that due to technical constraints the Admit Cards will be issued to them in the category which they have mentioned in the online application forms but their result would be declared in their base category as mentioned in annexure-A and annexure C.
4. Persons with disability, Punjab Category candidates who are eligible to avail scribe or extra time for the ibid examination and are desirous for the same may submit their request to the PPSC for scribe by **11.01.2023**. Persons with disabilities must submit copies of handicapped disability certificate and request for scribe/extra time if any and other eligibility documents by post or by email at pwdjudicial2022@gmail.com or by hand at the reception counter of the PPSC by 5.00 p.m. No such request shall be entertained thereafter.
