6. The application forms and requisite documents of provisionally

shortlisted candidates shall be scrutinized by the Commission. During the

scrutiny of application forms, if any provisionally shortlisted candidate is

found ineligible, then his/her candidature shall be cancelled by the

Commission.

7. The number of such provisionally shortlisted candidates may be more

than the number of posts in some categories to cater any cancellation of

candidatures arising out of the scrutiny of documents.
