1. In continuance of the Public Notices dated 15.04.2024 and 09.08.2024, it is hereby intimated that the candidates mentioned in the Annexure-A (Alphabetically) have provisionally qualified for the interview to be held on **27/08/2024 and 28/08/2024.** Detailed interview scheduled is attached as Annexure-A.

It is further informed that the venue for the interview shall be the Office of Punjab Public Service Commission, Baradari Gardens, Patiala and the reporting time for the Candidates shall be 8.30 AM (Morning Session) and 1.00 PM (Afternoon session). Late comers shall NOT be allowed to appear in the Interview.
3. The Candidates MUST bring the following documents **(IN ORIGINAL)** on the day of interview: -
  - (a) Proof of Date of Birth: Certificate of Matriculation / Higher Secondary.
  - (b) Proof of having passed Punjabi Language up to matric or its equivalent Standard.
  - (c) Degree/DMC or Diploma equivalent to degree in Architecture recognized by the Council of Architecture constituted under the Architects Act, 1972 and registration certificate as Architect under the Architects Act, 1972.
  - (d) Release order and Pension Payment Order issued by the concerned authorities (if applicable)
  - (e) Latest Punjab Residence certificate (for all Reserve Categories including female candidates who have applied in General Category) issued by competent authority.
  - (f) Caste/Reserved Category Certificate issued by the Competent Authority (if applicable).
  - (g) If ESM/LDESM(in original), Certificates/Documents mentioning the following
    - i) Date of Enrolment.
    - ii) Date of Release/Discharge.
    - iii) Reasons of Release/Discharge.
  - (h) Original Documents to claim exemption from Punjabi Language pass up to matric or its equivalent Standard (If applicable).
  - (i) Certificate as proof of age relaxation claim (if applicable).
  - (j) Certificate as proof of fee concession (if applicable).
  - (k) Any other certificate (if applicable).
  - (l) Duly filled Bio-data Sheet. The Performa of Bio-data sheet has been uploaded on Commission's Website.
